The Value of Simulation in the Nursing Education: The Challenges of E-Learning.

Abstract:

Nursing Education is thought to be successful when itintegrates both theoretical knowledge and psychomotor skills. In this regard, simulation represent an innovative method thatstimulates a number of teaching senses at the same time among learners. Simulation is a method which can be designed to reflect real-life conditions. Clinical simulation-defined by the National Council of State Boards of Nursing (NCSBN) as "an activity or event replicating clinical practice using scenarios, high-fidelity manikins, medium-fidelity manikins, standardized patients, role playing, skills stations, and computer-based crit ical thinking simulations"—has become an integral part of nursing education. In the context of the COVID19, all nursing programs have been shifted to distance learning including clinical/lab courses. This represented a great challenge toward achievement of clinical courses objectives as well as Intended Learning Outcomes.Moreover, exams were conducted as electronic/ online exams, making it hard for the educator to evaluate the competency level of the examinees and gave no chance for the students to be evaluated against the preset performance stanrds & criteria. In Jordan in general, distance learning for the nursing programs has not been relied on. Nursing education often depends upon active class attendance to ensure the strength and robustness of the nursing programs. This review has been conducted to search for potential solutions and possible electronic simulation delivery to students to enhance nursing students training for distance learning as plan "B" in case of unusual circumstances.
